## KEY IMMIGRATION SALARY THRESHOLDS, APPLICATION FEES & MAINTENANCE THRESHOLDS - FROM 24 NOVEMBER 2016

Category	Salary Threshold
Tier 2 (General)	<b>£20,800</b> per annum for New Entrants; <b>£25,000</b> for Experienced Workers – Rising to <b>£30,000</b> in April 2017 OR rate dictated by the relevant SOC code, whichever is higher
Tier 2 (ICT) Long Term Staff	<b>£41,500</b> per annum OR rate dictated by the relevant SOC code, whichever is higher
Tier 2 (ICT) Short Term/Graduate Trainee	<b>£30,000/£23,000</b> per annum OR rate dictated by the relevant SOC code, whichever is higher
Job Centre Plus/Universal Job Match Advertising	<b>£72,500</b> per annum or more = no advertising in Universal Job Match (UJM) formerly Job Centre Plus (JCP)
Tier 2 (General) High Earners	<b>£155,300</b> per annum or more, no RLMT (Resident Labour Market Test)
Tier 2 (General) Indefinite Leave to Remain	<b>£35,000</b> per annum

Category	Maintenance Thresholds – Level of Funds Required
Tier 1 (Entrepreneur) Migrants	For a consecutive 90 days: <b>£3,310</b> for entry clearance applications <b>£945</b> for leave to remain applications
Tier 1 (Graduate Entrepreneur) Migrants	For a consecutive 90 days: <b>£1,890</b> for entry clearance applications <b>£945</b> for leave to remain applications
Tier 2 Migrants and Tier 5 (Temporary Worker Migrant)	For a consecutive 90 days: <b>£945</b>
Tier 5 (Youth Mobility Scheme) Migrants	At time of application when visa fee is paid: <b>£1,890</b>
Dependants of Tier 1, 2 and 5 Migrants	For a consecutive 90 days: <b>£1,890</b> for dependants of Tier 1 (Entrepreneur) Migrants and Tier 1 (General) Migrants who have been in the UK for less than 12 months <b>£1,260</b> for dependants of Tier 1 (Graduate Entrepreneur) Migrants who have been in the UK for less than 12 months <b>£630</b> for all other applicants.

Please Note: These figures are subject to change as the UK Immigration Rules often change at short notice.
